2. Descripción y objetivos de la materia

Advanced oral communication es vital para cualquier profesional en sus estudios interdisciplinarios en Estudios Internacionales. En un mundo complejo y que cambia rápidamente, los Estudios Internacionales se relacionan con aspectos de la economía, política, geografía, historia, leyes, sociología, psicología y estudios culturales. Las políticas internas se ven constantemente afectadas por desarrollo externo y las naciones se ven obligadas a iniciar diálogos con fines de supervivencia en el sistema internacional. En el inicio, los británicos se enfocaron y rápidamente emergió una disciplina académica formal después de 1918 tanto en Europa como en los Estados Unidos, el Inglés ha sido el idioma predominante de la investigación e interacción en los Estudios Internacionales.

El curso está diseñado para ayudar a estudiantes que ya son bilingües a llegar a ser mejores comunicadores al mismo tiempo que estudian y practican cada forma de interacción entre y con los países, tales interacciones ocurren entre corporaciones; por ejemplo la OPEP y grupos sociales, la Comisión Internacional de Derechos Humanos.

Los contenidos, tareas y proyectos le ofrecen a los estudiantes oportunidades para desarrollar mejores habilidades en la comunicación oral con un énfasis en la preparación, organización y desarrollo de presentaciones profesionales y personales, discursos y debates relacionados con todos los aspectos de los Estudios Internacionales. Todas estas estrategias están directamente relacionadas con los estudiantes bilingües de Relaciones Internacionales.

Metodología

Lessons will be imparted in a theoretical and practical way. Topics will be presented during class, followed by written and oral practice. Students are expected to work autonomously and in groups to develop their argumentation skills. Critical Thinking will specially be accounted for and expected in oral presentations. Argumentation and debate skills will be promoted during the classes.

Criterios de Evaluación

Classwork:

Students will develop different topics to analyze, discuss and argue according to different steps and sequences of the argumentation theory. Students are expected to research each topic and find arguments and counterarguments to defend their viewpoints.

Students will be required to build mind maps and organizers to state their ideas as a starting point for later argumentation.

Individual and group work will be assigned in class.

Additionally, students are expected to research and prepare themselves for following oral presentations (First and Second Block) and for debates (Third Block)

Oral Evaluation:

Students will need to present their viewpoints and educated arguments to the class. A rubric in which different aspects of argumentation will be evaluated, will be provided for each oral presentation. Students will be evaluated in the contents of their presentations, good analysis of the topics, good posture and audience persuasion, as well as a correct use of the argumentation and debate structures. They are expected to distinguish arguing from fighting, therefore, self-awareness is expected at all times.

Debates:

Debates will follow different styles. Students will be graded according to the expectations of each kind of debate. A moderator will be assigned. Students need to follow debate rules and behave themselves accordingly. A winner of the debate will be chosen. However, no extra points will be awarded to winners. Each student will be evaluated according to their performance and argumentation.
